

Virtual Race General Liability and Waiver Release
Applicable to the AbbottWMM Global Run Club Race Participants

In consideration of the opportunity provided by World Marathon Majors LLC (“WMM”) to participate in an AbbottWMM Global Run Club Virtual Race, I hereby voluntarily state, represent and agree as follows:

I am voluntarily entering or agreeing to participate in a WMM Virtual race (the “Event”). I accept and acknowledge that the Event is physically challenging and carries with it risks that WMM cannot entirely eliminate. These include the risk of personal injury. I agree not to enter or participate in the Event unless I am healthy, medically able and properly trained and agree that it is my responsibility to consult with a physician prior to my participating in the Event to determine if I am medically able to participate in the Event.

I recognize that participation in the Event is a potentially hazardous activity and I willingly assume all risks associated with such participation, including, but not limited to, falls; contact with other people, or vehicular or other traffic; the effects of the weather, including heat and/or humidity, wind, cold, and wet or slippery surfaces; physical injury from the act of running itself, all such risks being known and appreciated by me.

Rules: I agree that I must:

1. act responsibly and sensibly at all times.
2. not participate if am under the influence of alcohol or non-prescription drugs.
3. follow any safety warnings or instructions displayed or given to you by in relation to the Event.

Liability and Waiver Release: Having read this Waiver/Release and knowing these facts, and in consideration of your acceptance of my application for the Event and allowing me to participate in the Event, I, for myself and anyone entitled to act on my behalf, do hereby waive, release, discharge, hold harmless, and covenant not to sue World Marathon Majors LLC or any Event sponsors, and other representatives, agents, and successors of each of the foregoing (the “Releasees”), from any and all present and future claims and liabilities of any kind, known or unknown, arising out of my participation in the Event (including, without limitation, personal injury or death and any theft, damage, destruction or loss of my property or belongings). I accept that WMM is not qualified to express an opinion that I am fit to safely participate. In the absence of any negligence or other breach of duty by WMM, participation in the Event is entirely at my risk.

I further acknowledge that the Releasees reserve the right to change the details (such as the date, start time, and distance) of the Event at any time for any reason, and I hereby waive and release any claims that I may have as a result of any such change.

Publicity Release: I accept and acknowledge that during the Event, various filming, photography and broadcasting may take place. By participating in the Event, I accept and acknowledge that photographs, filming and/or sound recordings (and/or any other record of my participation in the Event) may be taken of me (collectively, the "Content"). Where required under applicable law and in consideration of your acceptance of my application for the Event and allowing me to participate in the Event, I grant my consent, free of charge, to WMM (and its licensees and those authorized by it) to the use of such Content (including any copies), including, but not limited to portrait, picture, likeness, image and/or personal information, such as name, age, gender, domicile, race results, club affiliation, for any purpose (including, without limitation, exploitation and advertising) without compensation or credit. I acknowledge that any such use under this paragraph, and my agreement to such use, shall last in perpetuity.

Class/Collective Waiver: I hereby agree that all claims must be pursued on an individual basis only. By signing this agreement, I hereby waive my right to commence, or be a party to, any class or collective claims or to bring jointly any claim against the Releasees with any other person.

Acknowledgement of Understanding: I HAVE READ THIS WAIVER/RELEASE, AND I FULLY UNDERSTAND ITS TERMS AND CONDITIONS AND UNDERSTAND THAT I AM GIVING UP SUBSTANTIAL RIGHTS, INCLUDING MY RIGHT TO BRING ACTIONS AGAINST THE RELEASEES. I ACKNOWLEDGE THAT I AM SIGNING THE WAIVER/RELEASE FREELY AND VOLUNTARILY, AND THAT I INTEND BY MY SIGNATURE TO COMPLETELY AND UNCONDITIONALLY RELEASE THE RELEASEES TO THE FULLEST EXTENT ALLOWED BY LAW.

I EXPRESSLY AGREE THAT THIS WAIVER/RELEASE IS INTENDED TO BE AS BROAD AND INCLUSIVE AS PERMITTED BY THE LAWS OF THE STATE OF DELAWARE AND THAT THIS WAIVER SHALL BE GOVERNED BY AND INTERPRETED BY THE LAWS OF THE STATE OF DELAWARE. I AGREE THAT IN THE EVENT THAT ANY CLAUSE OR PROVISION OF THIS WAIVER/RELEASE SHALL BE HELD TO BE INVALID, THE INVALIDITY OF SUCH CLAUSE OR PROVISION SHALL NOT OTHERWISE AFFECT THE REMAINING PROVISIONS OF THIS WAIVER/RELEASE, WHICH SHALL CONTINUE TO REMAIN IN FULL FORCE AND EFFECT.
